



Dear Food Vendor,

Main Street Chanute is proud to announce the date of our 56<sup>th</sup> Artist Alley Festival. The 2025 Artist Alley Festival will be held on September 27, 2025. **Our festival hours will again be from 9 a.m. to 4 p.m.** We welcome your application for this long-standing, successful event.

Enclosed is the application to be completed by each food vendor for consideration in our festival. Pictures of your trailer/booth are welcomed and encouraged! **We also require a copy of your health license, menu, and tax ID number (unless you are not required by the State to have a tax ID number).** **PLEASE NOTE THE EARLY REGISTRATION DATE AND FEE SCHEDULE.**

**A complete menu with prices is to be included with the application, and you must be willing to delete some menu items to be included.** We are seeking a variety of food vendors and will limit the number of “like” vendors. For example: multiple snow cone vendors, etc. Vendors will be evaluated on a first come, first served basis. With the limited number of spaces, it is very competitive, and not all vendors that apply will be approved. All decisions made by the committee are final, and being guaranteed inclusion because of previous acceptance, is not guaranteed. It is to your benefit to provide as much information as possible, i.e., menu, trailer layout, complete application, pictures, etc., which impacts your acceptance. No applications will be considered without payment.

**EARLY** Full Line Food Vendor Fee is \$175.00 (MUST be received in the Main Street office by 6/30/25). Full-Line Food Vendor Fee after early registration date is \$200.00 and **EARLY** Single Item Food Vendor (ie. roasted nuts only or snowcones only) fee is \$100.00 (MUST be received in the Main Street office by 6/30/25). Single Item Food Vendor fee after early registration date is \$120.00. Non-profit food vendor fee is \$60.00. Electricity is included with vendor booth fee. If a supply trailer is required, there will be an extra charge of \$25.00 for electricity.

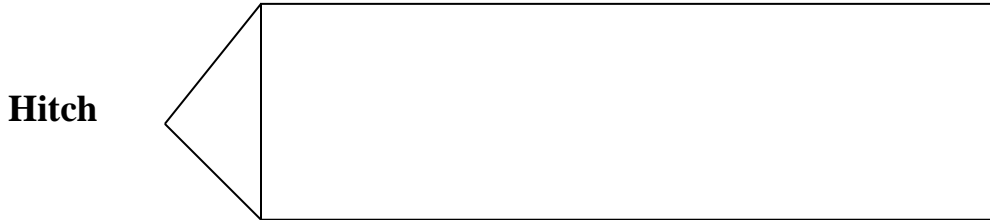

**PLEASE NOTE:**

All food vendors that have trailers will serve from their trailer. Vendor space is allowed only for the trailer. The only exception is for drop down condiment shelves that are permanently attached to the trailer. This means: all food & beverages will be sold from vendor trailer windows. **No "serving" tables will be allowed in the traffic ways.** This information is vital to properly place you within our food area.
